As part of the services performed by Spirit Pharmacy, we have access to special category of personal data - identifiable patient data.

# What information is being collected by Spirit Pharmacy?

General information:

- Name
- Address
- Date of Birth
- NHS number
- Telephone number
- Email address
- Surgery address
- GP name
- Medication

#### How is it collected?

All information is collected directly from the patient via:

- Prescriptions
- Spirit Pharmacy Website
- Telephone calls
- E-mails

### Why is it being collected?

This information is being collected to process prescriptions.

#### Information is collected for

The information is collected for accurate processing and dispensing of prescriptions.

#### How will it be used?

- To contact NHS and other Healthcare providers to ensure medication safety
- To provide medication to the patient
- To improve the health of patients

#### Who will it be shared with?

- All employees of Spirit Pharmacy
- NHS Prescription Services (for payment and audit purposes)



#### Where will the data be stored?

All data collected will be stored within the servers hosted in Microsoft's Azure cloud. The server is only accessible to Spirit and is managed by us too. The data is also stored on the NHS N3 secure network.

## **Automated decisions**

No automated decision making is used with the data collected.

# Your rights as a data subject

As a data subject, you have a number of rights. You can:

- Access and obtain a copy of your data on request;
- Require the organisation to change incorrect or incomplete data;
- Require the organisation to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing; and
- Object to the processing of your data where Spirit is relying on its legitimate interests as the legal ground for processing.
